But the main points so far were — residents like living in a village in the countryside, they dislike the speeding cars, they are not receptive to commercial development, unless it was a shop, they would like to see a lower density of domestic development should this happen, and they would not like to promote a green belt review. Cllr Romanski reported two potholes along the kerb outside 32 Priory Road, and felt this was very dangerous for mobility scooter users. Nothing new to report (c)Annual Residents meeting Rugby/Sports field use and play equipment – Cllr Randall suggested having the rugby field as dual use, with a running track around the outside and also using field as a sports field. Cllr Randall also wants to research funding which may be available for this, though Cllr Phipps in his Chairman's report said that previously these type of grants were not available to Parish Councils. Cllr Ireland thought this was a great idea and would help with researching funding/grants. Cllr Ireland thought it might be a good idea to post this on Facebook for comments from residents, and offered to do so. (d)Church Car Parking – Cllr Phipps reported via the Chairman's report that the Church have asked if they might use the Playing Field for overspill parking during the investiture of the new vicar on 22 nd June.
